

## Consent for photographic images

Dear Student

In the interests of promoting a positive profile, we would like, from time to time, to publish group photographs of our students on our web pages.

We would be delighted if you were willing to consent to the publication of photographs including your image on our web pages.

Moreover, fliers and printed brochures are planned for our company in future. In this context too we would like to use photographs of participants. It would be wonderful if you were able to give us your consent for this.

Names will be published together with photographs of individuals in the event of special distinctions/achievements.

**Important note:** You are free to choose whether you wish to give your consent or not. It will have no negative consequences if you choose not to give your consent. If you do give your consent, this can also be completely or partially revoked at any time. We will then remove your photograph from the web page within two weeks. The same applies to your name.

Should you have also given your consent for use in printed products, we will continue to use fliers/brochures already printed. In the event of a new edition, we will then of course ensure that your photograph and your name no longer appear in the brochure or flier.

Please be aware that our web pages are also accessible to search engines. You must therefore assume that your name and image will be findable by search engines.

**Further information on data privacy:** The processing of data is based in the first place on your consent. The purpose of the data processing is promoting our company profile as well as public relations. Concerning the use of your data in printed products, we also assume however that this data processing is also permitted on the basis of a balance of interests and, in the event of consent being revoked or of an objection, we can at least continue to use documents already printed. Image data of your personal information (in particular your name) will, in the event of publication, where appropriate be passed on to service providers involved. Deliberate transfer of your personal data to a 'third country' is not planned; however it cannot be ruled out, of course, that the data will be called up from countries where an appropriate level of data protection does not exist. We store and process your photographic data and information until your consent is revoked or there is an objection to their use in printed documents.

The contacts list gives details of how to reach our data privacy representatives. You also have the right, of course, to lodge a complaint with a data privacy supervisory body. We are legally obliged to inform you of this right.
